Hartlip Parish Council Meeting – 9 November 2022

The meeting was attended by County Councillor and Leader of Swale Borough Councillor Mike Baldock and Borough Councillors Alan Horton and Richard Palmer.

Two members of the public attended to enquire about the possibility of a twenty mile per hour speed limit for Mill Lane.

The Chairman drew their attention to the Parish Council item in the May 2022 Forum which is also to be found on the Parish Council website.

The item reported on the outcome of the speed survey which the Parish Council had arranged and had taken place in January 2022.

The analysis of the results by Highways experts had indicated that nothing would be gained by changing the current speed limit.

The speed survey had found only three cars travelling slightly over 40mph. Two of those were at approximately 5am.

The safety record along this road shows one collision since 1980 and that was in 2000.

The three Borough Councillors present added comments to support the view of the Highways Department.

The Parish Council is endeavouring to arrange for speed checks to be carried out in other parts of the parish to establish if any further speed limit changes can be achieved.
