Hartlip Parish Council Reporting - Agree any actions

- I. Recreational Ground to receive update
 - (a) Working Group Update. Members noted that the Zip wire had been successfully tensioned and that the equipment and protective matting was working well and in good order. Members noted that the Matting around the new adventure equipment in the play area had a channel around and that it still needed filling this is due to be actioned in November. The facility has received its final cut for the 2025 season and was in very good condition. It was noted that bench replacement program is listed within the 26/27 budget at one bench per year. Members RESOLVED to approve boundary maintenance by the contractor to raise the canopy, remove overhanging or dead branches and generally tidy the perimeter.
 - (b) No progressive update was available regarding a vehicle accident in Munns Lane that resulted in damage to the recreation ground fencing. Clir Harper and Clir Podolsky to prepare a response to their latest reply. Members also considered improvements to the Recreation Ground entrance to include the repair work. Also discussed was the available grants to carry out these improvements at limited cost to the public. NOTED.
- II. Parkland to receive update
 - (a) Members discussed options to improve the general condition of the footpath end of the facility which does not meet the necessary standards expected. Members discussed the option of creating a separate path section to create a public footpath / residents area that doesn't allow equine usage. Members noted that the path from the Parkland to The Street was overgrown and had been reported for action. NOTED.
- III. Highways Footpaths and Environment to receive update
 - (a) Members considered and RESOLVED to approve the instruction of a paid litter picker and the purchase of any PC owned signage of equipment.
 - (b) Signage Working Group there was no update. NOTED.
 - (c) Highways update. The approved no public cost HIP projects were progressing but no installation / completion date from KCC as yet. NOTED
 - (d) Public Consultation Update. Consultation went live on the website on 15 October and a paper version was posted through to each address by 5 November. The end date for the consultation is 31 December. NOTED
- IV. Village Hall Management Committee to receive update.
 - (a) No update was available. HPC are still awaiting HVHMC approval of the HPC members to join the committee. NOTED
 - (b) Members have received a communication from the committee regarding the water supply. There is no positive update on the Village Hall / Allotment water supply. HPC to communicate further with the committee in an attempt to finding a reasonable resolution.

Activity during October and November

Main local issues have been appeals and representing resident on school places and transport appeals plus SEND transport –

Roadworks and potholes – important people are encouraged to report as many as possible plus poor roads. KCC are now starting to fix stretches/sections of roads as well as busily fixing pothole.

KCC Budget – ASC is currently overspent – However the administration is looking at better ways of commission plus working jointly with the NHS in Kent and Medway to help reduce costs. The abandoned caravan on Iwade Road has now been reported and the police are aware and have an interest in it.

A big KCC project was to bring the Eurostar back to Kent. After organising and hosting an event held in September with interested parties it has been confirmed that Virgin Trains will be taking on the service, and they have given their assurance in writing that the Eurostar will resume services at Ashford and Ebbsfleet.

Education is stretching budgets particularly SEND and transport – KCC is looking at send provision and the high costs of Transport

Integrated children's services – some provision is being brought back in house owing to the high cost of private provision – this will save a minimum of 1.5 million a year. If all goes well this is a project that can be expanded on. The first property has been identified, purchased and is Swale. The home is a 2 bedded unit and will be for Kent looked after children with profound difficulties. Recruitment drive on fostering families following the launch of a short film commissioned jointly with other authorities "Run". A hard-hitting film highlighting the enormous benefits a foster family can make to a child's life. The film is available to watch on YouTube. KCC are working on a new project in the youth justice system, around restorative justice. More

to follow KCC are working with the CEO to get a cap removed for in-house apprenticeships for social workers. This will enable us to recruit more and rely less on expensive agency staff.

Looking at changing the policies around ECHP's assessment for the armed forces.

KCC Youth Voice basted an event at Detling Showground. The Rig Mental Health Conversation.

KCC Youth Voice hosted an event at Detling Showground, The Big Mental Health Conversation, showcasing the work being done to support people suffering with mental health issues.
